Basic On-Site Wastewater System Installation

This session will be presented by Subsurface Wastewater Unit staff and will provide installers of subsurface wastewater disposal systems with a basic understanding of the design, permitting, construction, and inspection processes contained in the Maine Subsurface Wastewater Disposal Rules (CMR 241). The various types of systems recognized will be discussed, with significant time devoted to identification and explanation of rule sections that relate directly to the construction of subsurface systems. A detailed description of the inspection process will be featured, stressing system construction aspects that are critical to the successful long-term functioning of subsurface systems. The use of erosion control devices and the Dig Safe process will also be covered.

Attendees who submit HHE-200 forms for two successfully completed system installations will be granted a certification number. The details of the voluntary Certification Program for System Installers will be covered during this session.

New Local Plumbing Inspector

Newly certified Local Plumbing Inspectors, and people seeking certification, will receive a thorough explanation of the permitting, inspection, and enforcement provisions of the Subsurface Wastewater Disposal Rules (CMR 241). Staff from the Maine Center for Disease Control's Subsurface Wastewater Unit will lead the session, and will focus on the review of HHE-200 forms for permitting, the system inspection process, the enforcement procedure, recent rules changes, and relationship of the Local Plumbing Inspector to the client, Site Evaluator, System Installer, and the Department of Health and Human Services. The class will also feature a presentation on internal plumbing rules. While this session is open to all, including Site Evaluators and System Installers, it will primarily be of interest to Local Plumbing Inspectors.

Advanced Septic System Training: Proprietary Device Workshop

This session will be introduced by Subsurface Wastewater Unit staff and will feature representatives from suppliers of proprietary devices relating to subsurface wastewater treatment and disposal. Each representative will describe their product and how its use can benefit the system user. Seven representatives will take part and have 45 minutes each to discuss their product and answer questions. Devices include concrete chambers, plastic chambers, fabric wrapped pipe, geotextile sand filters, and drip irrigation. These presentations will be more than sales talks and should be of interest to Local Plumbing Inspectors, Site Evaluators, and System Installers.

Subsurface Wastewater Disposal Rules: 2011 Revisions

A change in the rules means important changes for many in Maine, including Site Evaluators. In this class, participants will learn all that is necessary to know about the revised Subsurface Wastewater Disposal Rules (CMR 241). The Maine Center for Disease Control and Prevention's Subsurface Wastewater Unit began the revision process in December 2009, and after several meetings involving 16 stakeholder groups, the unit delivered the final product, which the state adopted earlier this year.

In this class, we will cover the rule development process and highlight the notable changes. The Subsurface Wastewater Disposal Rules include, for the first time, a "Key for Determining the Depth to Seasonal Groundwater Table". This table includes soil science terms and concepts that Site Evaluators must be familiar with and must use; this is especially true when making seasonal groundwater table and soils with an oxygenated groundwater table. (David Rocque, a soil scientist for the state, will be on hand to explain this new feature of the rules). The course will also examine the completely revised section in the rules on wetlands and water bodies. The section incorporates new setback requirements Site Evaluators must understand; the requirements were included to continue the DEP NRPA and Shoreland Zoning Permitting exemptions in the former rules.
