Subsurface Wastewater System Inspection

Attendees completing this day-long session will earn voluntary certification for conducting inspections of operating subsurface wastewater disposal systems. Maine's Department of Health and Human Services (DHHS) and Department of Environmental Protection (DEP) have developed a voluntary inspection program that is promoted for use at the time of property transfers. By law, this inspection is now mandatory in the coastal shoreland zone. This process, however, can be used any time a system owner wishes to document an existing subsurface wastewater disposal system. This session, presented by Division of Environmental Health, Subsurface Wastewater Unit staff and certified system inspectors, will cover the techniques needed to complete the DHHS State Inspection Report Form (HHE-240). Several examples of typical inspection scenarios will be discussed, and advanced techniques and equipment relating to existing system evaluation will be reviewed.

Basic On-Site Wastewater System Installation

This session will be presented by Division of Environmental Health, Subsurface Wastewater Unit staff, and will provide installers of subsurface wastewater disposal systems with a basic understanding of the design, permitting, construction, and inspection processes in the Maine Subsurface Wastewater Disposal Rules, CMR 241. Various types of recognized systems will be discussed, with significant time devoted to identification and explanation of rule sections that relate directly to the construction of subsurface systems. A detailed description of the inspection process will be featured, stressing system construction aspects that are critical to the successful long-term functioning of subsurface systems. The use of erosion control devices and the Dig Safe process will also be covered. Attendees who submit HHE-200 forms for two successfully completed system installations will be granted a certification number. Details of the voluntary Certification Program for System Installers will be covered during this session.

New Local Plumbing Inspector

Newly certified Local Plumbing Inspectors, and people seeking certification, will receive a thorough explanation of the permitting, inspection, and enforcement provisions of the Subsurface Wastewater Disposal Rules, CMR 241. Staff from the Division of Environmental Health, Subsurface Wastewater Unit will lead the session, and will focus on the review of HHE-200 forms for permitting, the system inspection process, the enforcement process, recent rules changes, and the relationship of the LPI to the client, Site Evaluator, System Installer, and the Department of Health and Human Services. This session will primarily be of interest to Local Plumbing Inspectors, but is open to all, including Site Evaluators and System Installers.

Advanced Wastewater Topics

This session will be presented by Division of Environmental Health, Subsurface Wastewater Unit staff, who will provide information on topics not addressed in detail in the Basic Onsite Wastewater System Installation session. The instructors will cover in detail how grades affect setback and separation distances; and treatment processes within an onsite sewage disposal system. The session will include a discussion of an investigation in the autumn of 2009 of a sewage-related hepatitis A outbreak. Installers, designers, and regulators should find this course particularly beneficial.

Ethical and Technical Issues for the Site Evaluator

This course will be presented by Division of Environmental Health, Subsurface Wastewater Unit staff and guest speakers, who will discuss ethical and technical subjects experienced by designers of subsurface wastewater disposal systems. The ethics portion of the course will focus on the point when a Site Evaluator stops being a consultant and becomes an advocate for a client. Technical topics will include calculation of fill and fill extensions, site evaluation requirements on filled sites, on-site monitoring of seasonal high groundwater, and the determination of whether a system is engineered or can be designed by a Site Evaluator. This course will primarily be of interest to licensed Site Evaluators, but is open to all, including Local Plumbing Inspectors and System Installers.
